HEALTH, SAFETY, AND ENVIRONMENT POLICY OBJECTIVES

For Greencells CEE, ensuring health, safety, and environmental protection at work is an ongoing commitment. To this end, the company has set the following specific objectives in the field of health and safety at work:

- Ensuring safe working conditions by reducing workplace incidents and developing a culture of health, safety, and environmental protection.
